Since the information sought list/details of cases as per available of CMIS record, NHRC are covered in 149 pages and as per RTI Act, 2005 provision applicant is required to pay/make payment @ Rs. 2/- per page for obtaining information sought. Therefore, you are requested to make payment of Rs. 2 X 149 = Rs. 298/- [Rs. Two hundred ninety eight only] in favour of NHRC for obtaining list of 3917 cases found to be registered in the various categories as mentioned in the RTI application.
- 4. In view of Para 2 above and action taken in the category wise complaints/cases as detailed above, it is to inform you that as per Central Information Commission's decision dated 19.06 2009, in the case of Rajendra Singh vs. Central Bureau of Investigation, in Complaint No. CIC/WB/2007/00967 dated 17.12.2007, where it is held that it is not open to the applicant under RTI Act to bundle a series of requests into one application unless these requests are treated separately and paid for accordingly. You may, if so desired, may seek the information about action taken by the Commission on the above-mentioned 3917 No. of cases on aforesaid category of incidents, any case by making the payment of RTI fee, for each case separately.
