1. The present application has been filed on behalf of Mr. Shiv Dutt Sharma, applicant for clarification of order dated 02.05.2022 passed by this Court with respect to the rate of interest that the applicant is liable to pay under Section 21(5) of the Mines and Minerals (Development and Regulation) Act, 1957 levied pursuant to judgment dated 02.08.2017 passed by this Court in the above Writ petition.

Taking into consideration the averments made in the application, for the present, the applicant is directed to make payment of compensation in respect of Raikela Iron Ore Mines, as demanded by the State Government, alongwith interest @ 12% per annum only within a period of two weeks from today, subject to the final order passed in this application.
